



#### **Policies**

The corporation of the Township of Minden Hills

By-Law No. 20-14

BEING A BY-LAW TO IMPLEMENT A SEWAGE

BEING A BY-LAW TO IMPLEMENT A SEWAGE (SEPTIC) SYSTEM MAINTENANCE INSPECTION PROGRAM.

- The Clean Water Act (2006):
  - Identifies 21 potential significant drinking water threats, including septic systems (S.O. 2006, Chapter 22).
- The Ontario Building Code (2012):
  - The Building Code Act (O.Reg. 332/12): A municipality may pass bylaws to establish and govern a Sewage System Maintenance Inspection Program.
  - Division C, Section 1.10 describes Sewage System Maintenance Inspection Programs Including Discretionary Programs
  - A Sewage System "Maintenance Inspection Program" shall apply to all sewage systems in the affected area, in this case the Township of Minden Hills.
  - The inspector appointed shall inspect all sewage systems for compliance with the requirements of Section 8.9 of Division B.



#### **Program Objectives**

- Re-Inspecting all classes of systems within the Township of Minden Hills.
  - Inspection for compliance with Section 8.9 of the Ontario Building Code.
- Intended to protect lake water, drinking water resources, public health, and the environment.
- Provide education and learning opportunities to system owners.
  - Owners are required to be present at their inspection.

Class 1: Privy, Outhouse, Composting Toilet, Incinerating Toilet

Class 2: Greywater Systems

Class 3: Cesspools

Class 4: Septic Tank and Leaching Bed

Class 5: Holding Tank









#### **WSP's Responsibilities**

Implement the Septic Re-inspection program on behalf of the Township of Minden Hills:

#### Our role will include:

- Notifying property owners about the program;
- Scheduling the inspections;
- Completing the inspections;
- Issue follow-up documents based on the inspection; and,
- Generate meaningful information based on the results of the program.
  - This will be included in an Annual Report to the Township.






### Scheduling


- Designated Inspection Years

  - → The Township has been divided into five (5) main inspection zones







What kinds of systems are inspected as part of this program?

This program will include inspections of all five (5) classes of on-site sewage systems, as regulated by the Ontario Building Code (Part 8). Some key details can be found below:

Classes of on-site sewage systems	Characteristics of system  Only accepts human waste.	How to prepare for your inspection  Ensure structure is vermin-proof (no possible access for mice, etc., into pit through doors/walls/windows) and that the pit is not exposed at grade.	
Class 1: Privy, Outhouse, Composting Toilet, Incinerating Toilet			
Class 2: Greywater Systems	Only accepts greywater (wastewater that excludes human waste).	Ensure that there are no illegal discharges from the system and the system does not receive human waste.

Dear Resident:

The Township of Minden Hills (the Township) has implemented a mandatory Septic Re-Inspection Program for its residents. WSP Canada Inc. (WSP) is administrating the Septic Re-Inspection Program on behalf of the Township and will be starting inspections in 2021. Residents are being contacted at this time to provide an introduction to the program, and to invite residents to Virtual Public Information Sessions (detailed further below). If you are receiving this letter, your property is <u>not</u> within the 2021 inspection zone and you will be contacted in your designated year with further information.



## Scheduling

- Inspections are completed between May and September each year
  - Weekday and weekend dates available (first-come, first-served)
- Inspections will be approximately
   45 minutes to 1 hour in duration
- Owner or a representative over the age of 18 is required to be present for the inspection
- Owners in Zone A will have until June 18, 2021 to book an inspection or one will be assigned for the same inspection year (2021)






## Scheduling: Boat Access Only Properties

- Select days will be available
- Neighbours are encouraged to coordinate, and can act as representatives for each other's inspections
- WSP must be notified of special access before the inspection
- Inspectors have their own transportation to meet at properties







## **COVID-19 Impacts**


- Inspectors will maintain a 2 m separation distance and wear face coverings
- Sewage treatment and disposal services are listed under businesses permitted to open

## **Septic Tank Inspection**


- Septic tanks provide a good overview regarding the health of the entire septic system
- The homeowner is required to uncover the septic tank lids prior to WSP visiting the property
  - Most tanks have two lids (one near the inlet and one near the outlet of the tank); both must be uncovered
  - If a pump tank is present, the lid must be uncovered





## **Septic Tank Inspection**

- WSP will estimate the sludge and scum layer depths through the use of a bailer apparatus
- WSP can then discuss if the frequency of tank pump outs is appropriate (i.e. too frequent, or not frequent enough)
- The tank does not have to be pumped for the inspection (the owner may pump the tank 1 month in advance of the inspection if desired)





#### **Metal Tanks**

- While metal tanks are no longer installed in Ontario, WSP has found a handful (about 1-2% of tanks) through our septic programs
- Sewer gases have a corrosive effect on metal tanks
- Caution should be taken if you are aware or suspect you might have a metal tank



## **Leaching Bed Inspection**

- WSP will complete a non-intrusive surface inspection of the leaching bed area to assess the presence or absence of signs/symptoms of leaching bed stress These may include:
  - Breakout of sewage onto the ground
  - Spongy and wet areas
  - Dead or over nitrified vegetation
  - Visible damage or other immediate concerns (i.e. the presence of above-ground pools, trees, a driveway on the leaching bed surface, etc.)





#### **Certificates and Remedial Actions**

- When there are no identified operation and maintenance issues, WSP will issue an Inspection Report and Certificate to the property owner
- Where there is identified operation and maintenance issues, WSP will issue a Remedial Action Letter to the property owner, in addition to the Inspection Report, describing the visual deficiencies observed by the inspector
  - This letter will outline the expected time frame for completion of the remedial action(s)
- All Inspection Reports and will also be forwarded directly to the Township of Minden Hills by WSP





Outhouse Pit Exposed (Class 1 Systems)	37	25%
No haulage agreement (Class 5 Systems)	7	39%
Metal Septic Tank or Holding Tank	1	<1%
Illegal Discharge (Class 2 Systems)	13	24%

# Frequently Asked Questions

#### Why does my septic system need to be inspected?

Septic re-inspections can provide system owners with advice on how to ensure the system has a long and useful life as well as being proactive with respect to environmental/lake water protection.

#### Why do I have to dig up my tank lids?

Access to your septic tank will be required for system maintenance regardless, and due to safety regulations, WSP cannot complete any digging.

#### What if I have an old system that we no longer use (such as an outhouse)?

All Classes of septic systems must be inspected if they are still in a state that could possibly be used; this can include an old outhouse being used as a storage shed, or a septic tank that still has plumbing connecting the system to the building and is not decommissioned.



# Frequently Asked Questions

#### What happens if I miss my inspection, or if (one or all of) my tank lids are still buried/not accessible?

If we arrive onsite and the tank lids are buried/not accessible, or an owner or representative is not present, we will need to rebook another inspection.

#### What if I can only be there on a weekend?

As your presence is required for the inspection (or a representative over the age of 18), you should contact WSP to book for a time that works for you.

#### Do I have to pump my tank before the inspection?

No, it is not required. Might as well wait for us to tell you if it's time for a pump-out!


